CIVIL AIR PATROL UNIFORM MANUAL

CAPM 39-1, dated 26 June 2014 as updated with Interim Change Letters 17 November 2015 and 05 March 2016, is supplemented as follows:

1. Montana Wing Patch.

1.1. To Para, 10.7.6 add:

The Montana Wing Patch, as approved on 01 October 2014, may be worn on the USAF-style Airman Battle Uniform, the USAF-style Battle Dress Uniform, the Corporate Field Uniform (Dark Blue, BDU style), the USAF-style Flight Duty Uniform, and the Corporate Flight Duty Uniform.

Wear of the Montana Wing Patch, as approved on 01 October 2014, is mandatory on the USAF-style Airman Battle Uniform, the USAF-style Battle Dress Uniform, and the Corporate Field Uniform (Dark Blue, BDU style).

The historic Montana Wing Patch may not be worn on any authorized uniform combinations.

1.2. To Para 5.1.1.3.2, 5.2.1.4.2, 8.2.4.5, 8.2.6.1, 8.3.4.5, add:

Wear of the Montana Wing Patch, as approved on 01 October 2014, became mandatory beginning 01 January 2016. The historic Montana Wing Patch may not be worn on any authorized uniform combination.

2. Montana Wing CAP baseball cap.

2.1. To Para 6.2.9., add:

Montana Wing CAP Baseball Cap will be black with Wing Patch emblem (approved 01 October 2014) embroidered centered, horizontally and vertically, on front panel.

This cap may be worn with the USAF-style Battle Dress Uniform, the Corporate Field Uniform (Dark Blue, BDU style), the USAF-style Flight Duty Uniform, the Corporate Flight Duty Uniform, and the Corporate Working Uniform (polo shirt).

As a Wing approved item, this cap may be worn with the USAF-style Airman Battle Uniform only within the physical boundaries of the State of Montana.

Previously authorized Montana Wing CAP baseball caps may no longer be worn with any authorized uniform combination.

Supersedes all previous MTWG Supplement to CAPM 39-1.

2.2. To Para 4.2.5.8, 4.2.6.8, 5.1.1.8, 5.2.1.8, 5.2.2.7, 8.2.7.3, 8.3.8, add:
Black Baseball Cap with embroidered Montana Wing Patch may be worn.

3. Cadet Shoulder Cords.

3.1. To Para 9.4.1., add:

The following shoulder cords are only authorized for wear by cadets. Wing/region approved items will be worn only within the boundaries of the authorizing commander. They are approved for wear only within the physical boundaries of the State of Montana.

Cadet graduates of CSTAR School may wear shoulder cords in the following colors:

- Cadet Officer - Black with Gold
- Cadet Non-Commissioned Officer - Black and Green
- Cadet Airman - Black and Red
