  - A. Two new RMR proposals
    - i. Proposal to allow wear of MTWG CSTAR shoulder cords anywhere in RMR
      - a. Carefully worded so that the proposal will not allow graduates of any cadet academies to wear the colored CSTAR chords, only graduates of the MTWG CSTAR
    - ii. Uniform supplement to CAPM 39-1 allowing designated medical personnel at large events (encampments, NCSAs, and other wing and squadron level events) to wear occupation-specific clothing while serving in a medical capacity
      - a. Certified nurses and emergency medical technicians, as well as cadets and senior members serving as health services officers may wear a scrub top with the standard working uniform pants and boots.
      - b. Certified medical doctors may wear a white lab coat with a scrub top undershirt with the standard working uniform pants and boots.

    - i. There are no regulations regulating drone use within search and rescue
      - a. Must obey current regulations of the FAA
